

You are, therefore requested to disseminate the same to all Kendriya Vidyalayas under your jurisdiction with the direction to strictly follow the instruction and also make the students of class XI and their parents aware of this scheme from the beginning of the session.

**1. Modifications in Scheme of Examinations and Pass Criteria for Class XI from session 2017-18 onwards:**

- (a.) The examination for class XI would be conducted in theory as well as in practical/project, depending upon the nature of the subject(s) and the marks allotted shall be as prescribed in the curriculum.
- (b.) The qualifying marks in each subject of external examination shall be 33%. However, in a subject involving practical/project work, a candidate must obtain 33% marks in the theory and 33% marks in the practical/project separately in addition to 33% marks in aggregate, in order to qualify in that subject
- (c.) In order to be declared as having passed the Class XI Examination, a candidate shall obtain 33% marks in all the subjects (Without additional subject). The pass marks in each subject of examination shall be 33%. In case of subject involving practical/project work a candidate must obtain 33% marks in theory and 33% in practical/project separately in addition to 33% marks in aggregate in order to qualify in that subject.
- (d.) A candidate **failing in one of the five subjects** of examination at Class XI shall be placed in Compartment in that subject provided he/she qualifies in all the subjects of internal assessment (As per CBSE Examination Byelaws Notification dated 29.11.2016 regarding Additions/ Amendments in Examination Bye-Laws, para 40.2.
- (e.) A candidate has to appear mandatory in session ending examination to be eligible to be consider for promotion to class XII.
- (f.) Report Card of class XI has two parts I & II:
  - i) Part I indicates subjects without practical/project. A students has to secure 33% in each subjects in a cumulative pattern (A + B) separately for promotion to next class XII.
  - ii) Part II indicates subjects with practical/project as given by CBSE curriculum. A student has to secure 33% marks in the theory exam in cumulative manner (A + B) and 33% in practical exam in each subject separately for promotion to next class XII.
- (g) The student has to appear in all the examinations to be declared pass /promoted.
- (h) No re-exam shall be conducted except on genuine grounds including medical.
- (i) Compartment Exam will be held by 10<sup>th</sup> April and result will be declared before 15<sup>th</sup> April so that student attends XII from 15<sup>th</sup> April onwards.
- a) A total of 10 grace marks spread all over the subject with a maximum of 04 marks in one subject can be given to a students who participated in the KVS National Meet/SGFI Meet in that Academic year. These marks can be given in the column of final weighted score to the extent needed to promote the student and not to bring him/her in the zone of supplementary case.
